Invitation to Bid for Installation of Isolation Building of Negros Occidental District Jail

1. The **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI)**, through the proposed **Maintenance Operations and Other Expenditures (MOOE) of 2022** intends to apply the sum of **Two Million Four Hundred Fifty-Eight Thousand Pesos (Php 2,458,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Installation of Isolation Building of Negros Occidental District Jail** with contract number **(CW6 002-22)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI)** now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred Twenty (120) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI)** and inspect the Bidding Documents at the address given below from **8:00 o'clock A.M. to 5:00 o'clock PM Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **May 13, 2022** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
6. The **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI)** will hold a Pre-Bid Conference¹ on **May 19, 2022, 2:00 o'clock PM** at **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI) Conference Room, 3rd Floor, Ignies Place, Brgy. Buhang, Jaro, Iloilo City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **May 30, 2022 at 2:30 o'clock PM**. Late bids shall not be accepted.



Bid opening shall be on **May 30, 2022, 2:45 o'clock PM** at the given address below **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI) Conference Room, 3rd Floor, Ignies Place, Brgy. Buhang, Jaro, Iloilo City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Valid PCAB License under Category – Small 'B' and above. A) Bid Bulletin must attach in the Bid Submission, B) If Bidders have joint Venture agreement (JVA), bidders must submit Special PCAB License for JVA

The **Bureau of Jail Management and Penology Region Office-VI (BJMPRO-VI)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
